Sub: Granting Rainforest Alliance Certification

Congratulations for successfully attaining Rainforest Alliance certification based on Rainforest Alliance Sustainable Agriculture Standard!

INDOCERT certification committee has decided to grant Rainforest Alliance certification to **Okayti Tea Estate** in accordance with RA standard. The certification granted to you is only applicable to the location and products mentioned in the certificate. Now you are eligible for submitting a request for approval for the use of the seal and sell the related product volumes as certified.
